**TOURNAMENT RULE**

1. Entries into the Championship Tournament are open to all members, in good standing, of the Treasure Coast USBC Association and have paid all USBC and TCUSBC Association dues.
2. Participants will use their highest USBC 2008-2009 yearbook average. However if the participant's average is ten (10) pins higher by January 1, 2010 the "10 pin rule will apply and the higher average will be used. If no current USBC yearbook or sanctioned USBC league average of at least 21 games is available by January 1, 2010, the participant will bowl SCRATCH. Only USBC averages will be used.
3. The TCUSBCA reserves the right to re-rate any bowler prior to scheduled bowling times. Bowlers have the right to appeal being re-rated in writing to the USBC within 15 days of the date of bowling or prior to the payment of prizes, whichever comes first. A bowler refusing to be re-rated will have their money refunded within 15 days after the completion of the Tournament. (Rule 319c).
4. If a bowler enters a doubles event, they must also enter the singles event and vice-versa. Bowler may enter the single, doubles and team event up to three (3) times provided that:
  - A. Team event bowlers must change at least two (2) members of their team each time they participate.
  - B. Doubles event participant cannot bowl with the partner more than once.
  - C. You can only enter "All Events" once. The first scores that you bowl in singles, doubles, and team event will count as your All Events score. Cash only once in singles.
5. All substitutions must be reported to the Tournament Officials as soon as possible. Once a substitute has completed one (1) frame in the event, they must complete the series. No more than 50% of the original lineup may be substituted in any event. Substitutes are not required to reimburse the original entrant any fees paid, or forfeit and prize(s) won.
6. It is the sole responsibility of the each Bowler to verify the accuracy of all information. Failure to do so may result in disqualification.
7. **All Entry Fees must be paid when the entry form is submitted.** TCUSBCA will not accept partial payments. Payments must be made by check or money order. Make checks payable to, Treasure Coast USBS Association. Any returned check will be charged Bank fees of \$32.00. Tournament management shall not accept additional entries after the closing of entries.
8. Team Captains are responsible for checking in their team and receiving lane assignments at least ½ hour prior to squad time.
9. Scores bowled in the regular handicap events will also be used for the optional scratch events. To participate in an optional scratch event, a bowler must also enter the handicap event.
10. Bowling shall be in accordance with a previously arranged schedule. Bowling lanes will be assigned. Any Team or bowler arriving late shall play with the score count beginning in the current frame being bowled. A Bowler or Team, who misses one or more frames by not being ready to bowl, in turn shall receive no score for the frame(s) missed. No absentee scores are permitted. Pacers are not allowed.
11. In the event of a tie for (first) Championship position, a one (1) game roll off will be used. The total pin fall, including handicap, of the roll off shall determine the Championship position,
12. Current PBA Member: No more than one (1) on any one team, and only 1 on doubles pair.
13. Any protests or appeals pertaining to eligibility, scoring, or playing rules must be filed in writing with the Tournament Officials within 15 day after the completion of the event.
14. Minimums of eight (8) entries per squad time are required, or the squad may be canceled. Those affected will be moved or their money refunded within 15 days after the completion of the Tournament.
15. All bowlers regardless of average must comply with the provision of USBC Rule 319d. Failure to comply with these provisions is cause for a forfeiture of entry fees and prize winnings.
16. The prize fund will be returned 100%.
17. NO ENTRY FEES WILL BE REFUNDED AFTER THE SCHEDULES ARE POSTED. (USBC Rule 314).
18. All USBC Tournament Rules will apply.
